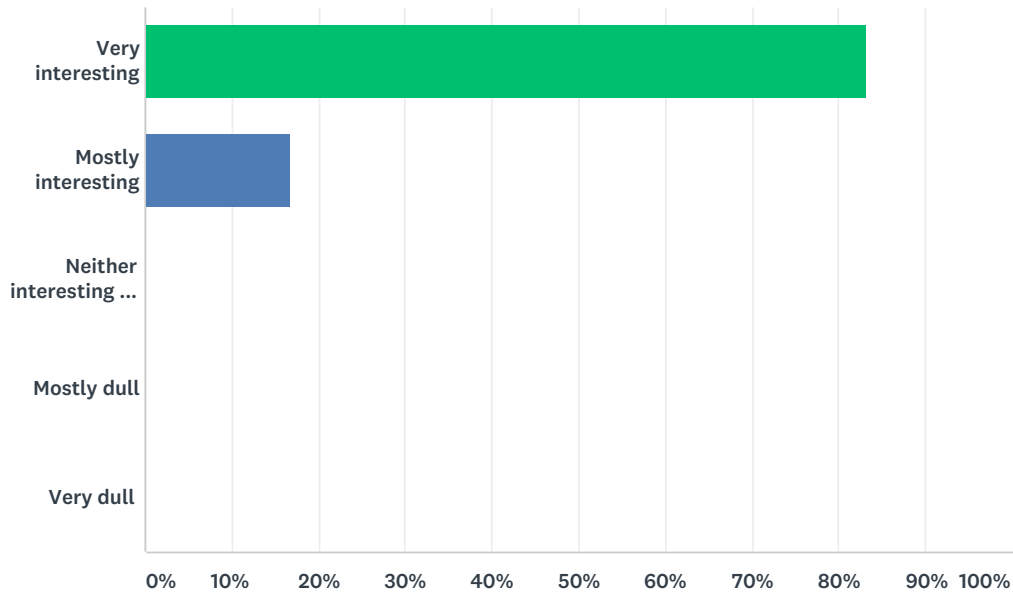


### Q3 How interesting did you find the jury process?

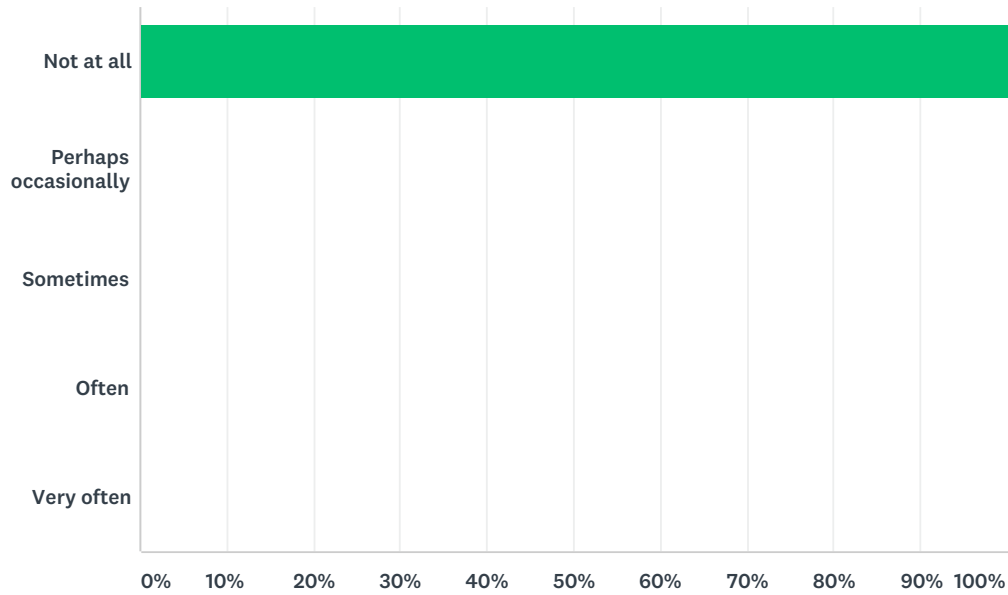
**Q4 Overall, what was it like participating in the citizens' jury over the 3.5 days? Please say 3 things in 3 words to sum up your experience.**

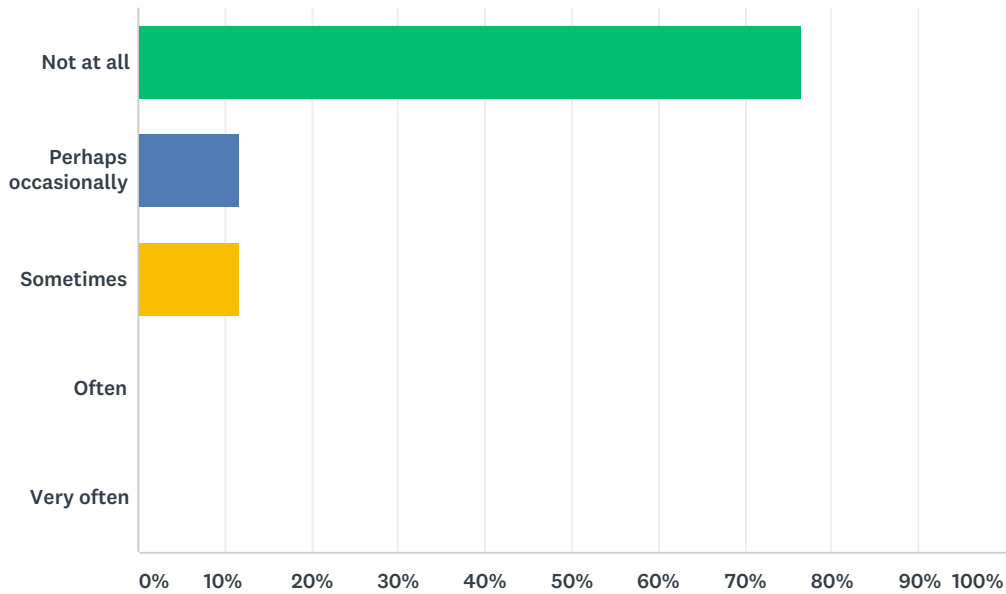

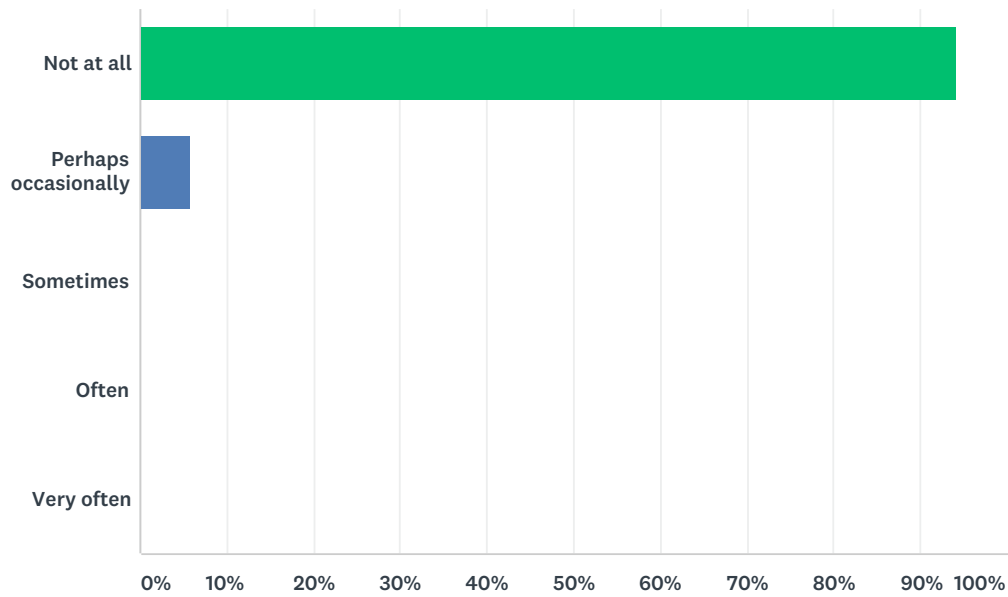

## Q7 Did you ever feel that anyone outside the jury room tried to influence you towards particular conclusions?

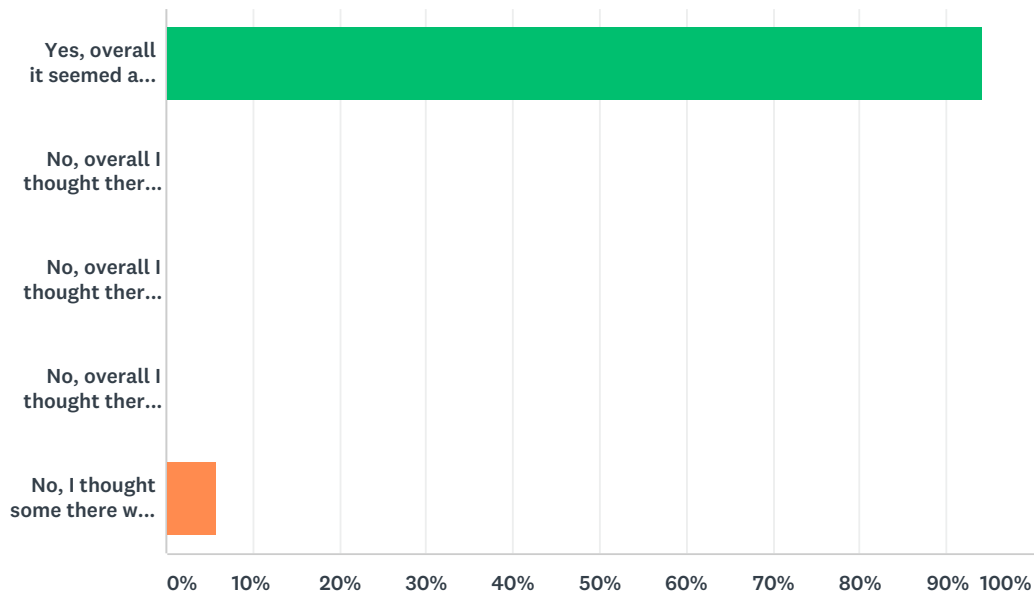

### Q8 Do you feel that overall that the information you were given provided a fair balance of information about the location of the new hospital?

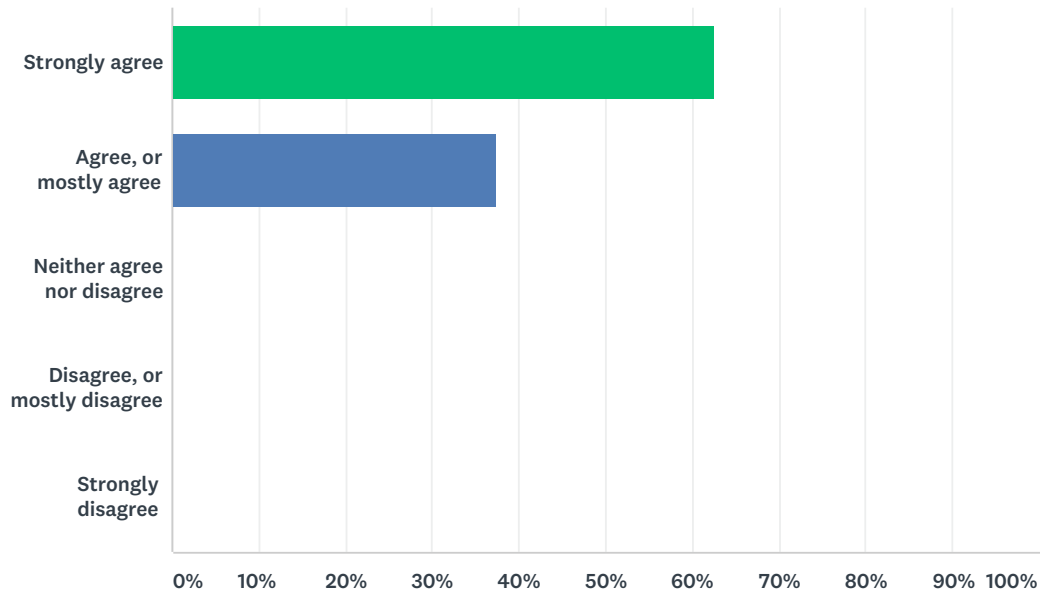
